## Bare boat charters 2019 Terms & Conditions

### Charter rates in Euro referring to weekly charter period, including:

- Current VAT
- Use of yachts with following equipment: VHF, Radio CD, GPS, Autopilot, Echo sounder, Speedometer, Dinghy with, Warm water supply, Spray hood, Bimini/tent, Blankets.

### Charter rates do not include:

- Fuel, water, provisioning, extra linen running expenses & mooring fees
- Provisions: Ask for our provisioning form. Fill it in and email it to us. We'll take care of it and on your embarkation, your food and beverages will be on-board.
- Transfer services from Airport to Base.

### Compulsory per charter

- Starter Pack (not commissionable, payable at the base in cash): End cleaning, Outboard engine, Fuel for the outboard engine, Cooking gas, Water, Linen (2 sheets, 1 pillow case, 1 bath towel per person per week, Harbour fees for the first & last night, 1 bottle of Greek wine complimentary on all yachts)
- Yachts with 3 cabins 120€, 4 cabins 160€, 5 cabins 200€, 6 cabins 200€
- Catamarans: up to 39' 200€, 40' and up 240€
- Embarkation: starting date from 17h00.
- Disembarkation: ending day by 09h00.
- Compulsory: return to base the evening before disembarkation, at 18h00, the latest. Check in/out procedures time is part of the charter period.

### Optional Crew services:

- Skipper: 150€/per day plus provisioning
- Cook: 140€/per day plus provisioning, serving 3 meals daily.
- Hostess: 130€/per day plus provisioning, serving breakfast and one light meal daily.

### Security Deposit

The said refundable Security Deposit (1.000-3.000 euro) is required upon embarkation and will cover any damage or loss of the yacht and her equipment during the cruise.

### Insurance Deposit:

- For Yachts with 1.500 euro Deposit: 225 euro non-refundable INSURANCE DEPOSIT
- For Yachts with 2.000 euro Deposit: 275 euro non-refundable INSURANCE DEPOSIT
- For Yachts with 2.500 euro Deposit: 300 euro non-refundable INSURANCE DEPOSIT
- For Yachts with 3.000 euro Deposit: 350 euro non-refundable INSURANCE DEPOSIT

## **Damage Waiver / Security deposit reduction:**

- For Yachts with 1.500 euro Deposit: 150 euro non-refundable + 350 refundable
- For Yachts with 2.000 euro Deposit: 200 euro non-refundable + 450 refundable
- For Yachts with 2.500 euro Deposit: 225 euro non-refundable + 600 refundable
- For Yachts with 3.000 euro Deposit: 250 euro non-refundable + 750 refundable

## **Insurance / All boats are insured against:**

- Risks arising from liability to third parties and damage to hull, machinery & equipment
- Third party liability
- Sea pollution liability
- A deductible provision is applied, depending on the yachts value.

## **Payments**

A down payment will secure your reservation. Final payment of the charter fee is due 4 weeks prior to your arrival. 1-2 weeks before your starting date you will receive details for your local contact person at the marina and a list of suggested items to bring with you from home for your sailing adventure!

- The down payment (40% of the total charter fee, depending on the booking date) is paid by bank's transfer to our account upon contract signing.
- The balance (60% of the charter fee, depending on the booking date) is paid 4 weeks prior to embarkation.

Down payment by wire transfer -without surcharge- or on line payment with credit card -with related credit card fee on top-, should be settled within 1 week

## **Cancellation Policy**

### **In case you have to cancel your booking, the following terms apply:**

- For bookings cancelled up to 91 days prior to embarkation date full refund, however there is an administration fee applicable of 10% of the charter price.
- For bookings cancelled between 90 and 60 days prior to embarkation, 30% of the total cost of the charter is charged.
- For bookings cancelled between 60 and 30 days prior to embarkation, 50% of the total cost of the charter is charged.
- For bookings cancelled less than 30 days prior to embarkation, 100% is charged.
- Refunds will be made only in the event that the yacht will be re-chartered for the same period and at the same price.
- As with any vacations, we strongly recommend that your sailing trip be insured against any unforeseen circumstances.
- No show / withhold of every paid amount.
